5. A Planning Meeting with PSDS/In-Charge of the Districts, District Sports Coordinators, District Partnerships Focal Persons will be on May 13, 2024, 10:00 A.M. at SDO Conference Hall.
6. The proceeds of the activity will be taken care of by respective PSDS/In-Charge of the Districts and shall be remitted to the SDO Cash Section not later than May 16, 2024.
